98-3	11-12-1998	Extending the expiration date of the cable television franchise agreement with Mark Twain Cablevision Limited Partnership
2006-2	2-16-2006	Authorizing the Melrose Telephone Company, its successors and assignees, to direct, own, operate, and maintain a cable communications system in the city.
2006-3	3-9-2006	Extending the term of the cable television franchise agreement with US Cable of Coastal-Texas L.P. (US Cable).
